

Terms and Conditions for Congress Participants EHEDG World Congress 2024

1. Registration

- 1.1 All Congress Participants must register online through the Congress website.
- 1.2 The registration is only valid once the registration fee has been paid in full.
- 1.3 The registration is personal and non-transferable.

2. Fees & Closing Dates

2.1 Congress Participant Fees

Fee for Participants who have submitted a Poster

EUR 595.00 excl. 20 % VAT

Fee for the second Participant born after 1989 (The year the EHEDG Foundation was established)

EUR 89.00 excl. 20 % VAT

- 2.3 The Participant fee for all participants, except the second Participant born after 1989, includes participation in the congress, congress documentation download options, and all meals and drinks throughout the day, including the Congress dinner.
